What is a LAP?

Is a set of decisions made by a TA in consultation with its community about the sale and supply of alcohol in its geographical area.

Once a LAP is in place, licensing bodies will have to consider the policy when making decisions on licence applications



What does the Act say?

A LAP may provide differently for different parts of its district; and

May apply to only part (or 2 or more parts) of its district; and

May apply differently for which licenses of different kinds are held or have been applied for





Two or more TAs may adopt a single LAP for their districts; and In that case, this subpart applies as if they were a single TA with a single district



Content of Policies

LAP may include policies on any or all of the following matters relating to licensing (and no others)

Location of licensed premises by reference to broad areas

Location of licensed premises by reference to proximity to premises or facilities of particular kind or kinds

Whether further licences (or licences of particular kind or kinds) should be issued for premises in the district concerned, or any stated part of the district

Maximum trading hours

The issue of licences, or licences of a particular kind or kinds, subject to discretionary conditions

One-way door restrictions



Regard to when producing a draft LAP

Objectives and policies of its district plan; and

Number of licenses of each kind held for premises in its district, and location and opening hours of each of the premises; and

Any areas in which bylaws prohibiting alcohol in public places are in force; and

Demography of district's residents; and visitors (tourist and holidaymakers) and

Overall health indicators of the district's residents; and

Nature and severity of the alcohol-related problems arising in the district




Regard to when producing a draft LAP

Must not produce a draft policy without having consulted the Police, inspectors, and Medical Officers of Health, each of whom must, if asked by the TA to do so, make reasonable efforts to give the authority any information they hold relating to any of the matters in sec 78
