#### **SPEAKERS PROFILES**



#### JUDGE ANTHONY P. WARTNIK

Judge Anthony (Tony) Wartnik has a long and distinguished career in law and has been recognised by his peers for his outstanding contribution to his field. Tony has been a Judge since 1971, retiring as the Senior Judge of the Superior Court in King County Washington State 2 years ago after nearly 25 years on that court.

During that time he has served as the Presiding Judge for the Juvenile Court, Chief Judge for the Family Law Court, and Chair of the Family and Juvenile Law Committees. He was also the Dean Emeritus of the Washington Judicial College, Chair of the Judicial College Board of Trustees and Chair of the Washington State Supreme Court's Judicial Education Committee.

As well as chairing innumerable other committees and projects, he Chaired the Governor's Advisory Panel on Fetal Alcohol Syndrome (FASD) and the Human Relations and Training Sub Committee of the Unified Family Court Task Force for the King County Superior Court. In addition, Tony served on the Governor's Task Force on Decision Making Models in Corrections.

Tony is currently the consultant to the University of Washington Medical School Fetal Alcohol Drug Unit (FADU) and the King County Superior Court on the subject of FASD in the criminal justice system. Tony has been a presenter at numerous local, national and international conferences on FASD.



**KATHRYN A. KELLY** 

Kathryn (Kay) Kelly is the Project Director of the FASD Legal Issues Resource Center at the University of Washington, Seattle. The Center is part of the Fetal Alcohol and Drug Unit within the Department of Psychiatry and is a joint project of the University of Washington, School of Law and the University of Washington, School of Medicine.

As Project Director Kay works with judges, attorneys and family members in dealing with the wide range of issues that arise when individuals with Fetal Alcohol Spectrum Disorders (FASD) are charged with criminal offences, either in Juvenile or Adult Court.

Since 2005 Kay has been the Project Director of the Substance Abuse Mental Health Services Administration (SAMHSA) funded project "Improving the Functioning of Individuals With FASD in the Seattle Area Criminal Justice System". Kay has spoken about FASD and the Law at numerous conferences and trainings and has published resources on the topic.

Prior to helping found the FASD Legal Issues Resource Center, Kay was an investigator for the Habeas Corpus Unit of the Federal Public Defender in Los Angeles, California and worked as an investigator in capital punishment cases in California and Mississippi. She was a Federal Probation Officer in U.S. District Court in Los Angeles for twenty years and a Los Angeles County Probation Officer for nine years.
